Privacy policy

Personal information is data that can be used to identify or contact a single person.

Here are some examples of the types of personal information we may collect and how we may use it:

What personal information we collect

Information You Give Us: We receive and store any information you enter on our Web site or give us in any other way. Information from Other Sources: We might receive information about you from other sources and add it to our account information.

How we use your personal information

We may process your personal information: for the purposes described in this Privacy Policy, with your consent, for compliance with a legal obligation to which SPORTS MOBILITY SYSTEM FLORIDA LLC is subject, for the performance of a contract to which you are party, in order to protect your vital interests, or when we have assessed it is necessary for the purposes of the legitimate interests pursued by SPORTS MOBILITY SYSTEM FLORIDA LLC or a third party to whom it may be necessary to disclose information.

For certain online transactions we may also validate the information provided by you with publicly accessible sources.

Collection and Use of Non-Personal Information

Cookies and Other Technologies

If you do not wish to receive ads targeted to your interests from SPORTS MOBILITY SYSTEM FLORIDA LLC advertising platform, you can choose to enable limited Ad Tracking and opt out of receiving such ads regardless of what device you are using. SPORTS MOBILITY SYSTEM FLORIDA LLC also uses cookies and other technologies to remember personal information when you use our website and online services. Our goal in these cases is to make your experience with websites more convenient and personal.

If you want to disable cookies, go to preferences of the web browser and then to the privacy pane to manage your preferences. On your mobile device, go to Settings, to the Privacy & Security section, and tap on "Block Cookies" to manage your preferences.

As is true of most internet services, we gather some information automatically and store it in log files. This information includes Internet Protocol (IP) addresses, browser type and language, Internet service provider (ISP), referring and exit websites and applications, operating system, date/time stamp, and clickstream data. We use this information to understand and analyze trends, to administer the site, to learn about user behavior on the site, to improve our product and services, and to gather demographic information about our user base as a whole.
